

## Notes on example Muslim-Muslim Nikah Nama

These notes are in reference to completing the Muslim-Muslim Nikah Nama v.220107.

The original format from which Nikah Nama v.220107 was adapted from, was the Pakistani Nikah Nama form as prescribed under its Muslim Family Laws Ordinance, 1961 (VIII of 1961), between two Muslims.

### **1.Name of the Brides:**

Write the names of the older bride first under **i.** then the name of the younger bride under **ii.**

### **2.Town and country in which the nikah took place:**

The location of where the ceremony is taking place.

### **3.i. Name of bride and her parents/guardians with their respective residence:**

Name the older bride and her parents or guardians. Include the individual address of residence of each named person in this section.

### **3.ii. Age of bride:**

State the age of the older bride at the time of this marriage.

### **3.iii. Whether bride is married, unmarried, widow or divorced:**

State whether the older bride is currently married, unmarried, widowed or divorced.

### **4.i. Name of bride and her parents/guardians with their respective residence:**

Name the younger bride and her parents or guardians. Include the individual address of residence of each named person in this section.

### **4.ii. Age of bride:**

State the age of the younger bride at the time of this marriage.

### **4.iii. Whether bride is married, unmarried, widow or divorced:**

State whether the younger bride is currently married, unmarried, widowed or divorced.

### **5. Names of the witnesses to the marriage and of the contract, and their residence:**

State the name of both witnesses and their individual address of residence.

### **6. The date when the marriage was celebrated:**

State the date when this marriage is or was celebrated.

### **7. The amount of Mehr and given to:**

State the amount of mehr if it is monetary or state the gift given in mehr. Also state who it is being given to, i.e the name of the younger bride.

**8.The amount of Mehr and given to:**

State the amount of mehr if it is monetary or state the gift given in mehr. Also state who it is being given to, i.e the name of the older bride.

**9. Who has power of divorce, under what conditions:**

State whether both or one of the brides will have the right to initiate divorce and if any particular circumstances will cause the initiation of divorce. Detailed description can be stated in an appendix to the nikah nama.

**10. Whether any document was drawn up at the time of marriage relating to maintenance, etc. If so, contents thereof in brief:**

State whether there is an appendix to the nikah nama and its title with any sub-headings.

**11. Whether the brides have any existing partners, and, if so, whether they have secured permission to contract another marriage:**

State whether if either of the brides are currently married and state the evidence that allows for another marriage to take place.

**12. Date of registration of marriage:**

State the date of this nikah nama being witnessed and signed.

**13.Signature of the Bride:**

Signature of the older bride.

**14.Signature of the Bride:**

Signature of the younger bride.

**15.Signature of witnesses of the marriage and the contract**

Signature of two witnesses to the reading and signing of the nikah nama.
